Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

# Handling Procedures

- 1. Open vial.
- 2. From a single tube of #416 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well

4. Use several drops of this suspension to inoculate a second tube of broth, a slant and/or a plate.

#### Notes

After 48 hours, growth is evident by turbidity in the broth and the formation of small colonies on the slant and/or plate. Growth is best in broth culture or on biphasic slants. Colonies are white, smooth, entire, convex and opaque. Cells are thick rods that occur in pairs and chains.
