used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

1. Open vial according to enclosed instructions.
2. Under anaerobic conditions, withdraw 0.5 ml of the recommended broth from a single tube (5 to 6 ml) and rehydrate the entire vial contents.
3. Aseptically transfer this aliquot back into the broth tube. A slant may be inoculated with 0.1 ml of the cell suspension. Also, streak several blood agar plates to check for colonial morphology and purity.

4. Incubate tubes and one blood plate under anaerobic conditions at 37°C. Incubate second agar plate aerobically at 37°C for aerobic contamination check.

5. Within 48 to 72 hours, growth is evident by good turbidity. No growth should occur on agar any of the plates.

Notes

Straight slender rod shaped bacteria that are Gram negative and motile. No spore formation has been detected.

ANAEROBIC CONDITIONS:

- Tubes of media are placed under a gassing cannula system hooked to a source of oxygen free gas.
- All transfers are performed while the test tubes are on the cannula system with a gentle stream of oxygen free gas flowing through the system.
- As the test tubes are removed from the cannula system each is sealed with butyl rubber stopper thus maintaining the anaerobic headspace. 100% nitrogen or 80% nitrogen-20% carbon dioxide gas mixture is typically employed as the oxygen free gas source.
- Resazurin is a commonly used redox indicator that is pink when the redox potential is above 50 mv., and colorless when the redox potential is below 110 mv. i.e. highly reducing. Most strict anaerobes require this low redox potential for optimum growth.
- To obtain a fully reduced medium, it is necessary that the medium be anoxic and that a reducing agent be added. Common reducing agents are sodium sulfide, cysteine, dithiothreitol, and titanium citrate.
