Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #2275 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Inoculate additional tubes of broth and slants. Plates may also be inoculated to test for purity.

4. Incubate broth tube at the recommended temperature for 48 hours.

#### Notes

Cells are Gram negative thick rods, single and in pairs. Colonies are tiny, round, entire, with a slight pinkish pigmentation.
