Staphylococcus aureus strain RN4220 was selected for transformability with DNA from *Escherichia coli*. It has a mutation in *sau1 hsdR*, which makes it restriction deficient and a good intermediate cloning host.

Handling Procedures

1. Open thawed vial.
2. Aseptically transfer the entire contents to a 5-6 mL tube of #18 broth.
Additional test tubes can be inoculated by transferring 0.5 mL of the primary

- broth tube to these secondary tubes.
3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
 4. Incubate at 37°C for 18-24 hours.
