Listeria monocytogenes strain LMP18-H8393 was isolated from chocolate milk. This strain was part of the 2018 PulseNet-GenomeTrakr joint proficiency test exercise. It is typed as serotype 1/2b and has applications in food testing and enteric disease research.

Handling Procedures

1. Open thawed vial according to enclosed instructions or visit www.atcc.org for instructions.
 2. Aseptically transfer the entire contents to a 5-6 mL tube of #18 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
 3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
 4. Incubate at 37°C for 24 hours.
