Escherichia coli strain ECP17-1298 was isolated in the United States from a human. This whole-genome sequenced bacterium is typed as serotype O157:H7 and was part of the 2017 PulseNet-GenomeTrakr joint proficiency test exercise. It has applications in food testing, enteric disease research, and infectious disease research.

instructions.

- 2. Aseptically transfer the entire contents to a 5-6 mL tube of #18 broth.

  Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
- 3. Use several drops of the primary broth tube to inoculate a #18 plate and/or #18 agar slant.
- 4. Incubate at 37°C for 24 hours.
