## Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of the recommended broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or  
1.0 ml pipette and use to rehydrate the entire pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.

4. Heavily inoculate a slant of #90 and/or a plate of #173 agar.
  5. After growth has been achieved, additional transfers may be made.

## Notes

\*Strain was received as the proposed type strain of *Mycobacterium ontariense* (NRCM 01-17). However, the depositor asked us to change the name of the culture and emend the deposit form to *Mycobacterium elephantis* and delete the type strain designation.

Growth on solid medium requires three to seven days incubation. Colonies on #173 plates are tiny, clear and circular. A yellow pigment appears with extended incubation. Culture will also grow on Brain Heart Infusion Agar (Difco 241830).
