Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

- 1. Open thawed vial.
- 2. Aseptically transfer the entire contents to a 5-6 mL tube of #18 broth.

Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.

- 3. Use several drops of the primary broth tube to inoculate a #18 plate and/or #18 agar slant.
- 4. Incubate at 37°C for 18-24 hours.
