This drug-resistant bacterium was isolated in 2014 from the abscess of a 1-year-old male in Australia. This product can be used for all stages of the discovery and development process for novel antimicrobials and therapeutics, molecular-based detection assays, and updated sterility protocols.

## Handling Procedures

1. Open thawed vial.
  2. Aseptically transfer the entire contents to a 5-6 mL tube of #44 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
  3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
  4. Incubate at 37°C in 5% CO<sub>2</sub> for 18-24 hours.
