For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 2. Rehydrate the entire pellet with approximately 0.5 mL of #44 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #44 broth. Additional test tubes can be inoculated by transferring 0.1 mL of the primary broth tube to these secondary broth tubes.
- 3. Use 0.1 mL of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
- 4. Incubate at 37°C for 24-48 hours in an atmosphere of 5% CO₂.

Notes

A jump may be needed to obtain sufficient growth. Growth may need to be established in broth before growth on agar can be achieved.
