ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Handling Procedures

1. Open vial according to enclosed instructions or visit www.atcc.org for

instructions.

2. Rehydrate the entire pellet with approximately 0.5 mL of #44 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #44 broth. Additional test tubes can be inoculated by transferring 0.1 mL of the primary broth tube to these secondary broth tubes.
3. Use 0.1 mL of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
4. Incubate at 37°C for 24-48 hours in an atmosphere of 5% CO₂.

Notes

A jump may be needed to obtain sufficient growth. Growth may need to be established in broth before growth on agar can be achieved.
