- 2. Rehydrate the entire pellet with approximately 0.5 mL of #814 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #814 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.
- 3. Use several drops of the primary broth tube to inoculate a #814 plate and/or #814 agar slant.
- 4. Incubate at 37°C for 24-48 hours in an atmosphere of 5% CO₂.
