Description

Quantitative Genomic DNA from *Salmonella enterica* subsp. *enterica* serovar Bareilly strain GTVSS-004 is derived from a component of the GenomeTrakr Validation Strain Set (GTVSS) for food testing and can be used as a next-generation sequencing (NGS) control for SNP discovery. This molecular standard supports assay development, verification, and validation, and can also be used to monitor day-to-day test variation and lot-to-lot performance of molecular-based assays. The quantitative format allows for the generation of a standard curve for quantitative PCR (qPCR) to determine bacterial load.
