Description

Quantitative Genomic DNA from *Klebsiella pneumoniae* strain GTVSS-027 is derived from a component of the GenomeTrakr Validation Strain Set (GTVSS) for food testing and can be used as a next-generation sequencing (NGS) control for contamination detection. This molecular standard supports assay development, verification, and validation, and can also be used to monitor day-to-day test variation and lot-to-lot performance of molecular-based assays. The quantitative format allows for the generation of a standard curve for quantitative PCR (qPCR) to determine bacterial load.

 3. Briefly centrifuge the tube before opening to ensure all liquid is at the bottom.
