This drug-resistant bacterium was isolated in 2014 from the reproductive system of a 17-year-old male in Taiwan. This product can be used for all stages of the discovery and development process for novel antimicrobials and therapeutics, molecular-based detection assays, and updated sterility protocols.

Handling Procedures

1. Open thawed vial.
2. Aseptically transfer the entire contents to a 5-6 mL tube of #814 broth.

Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.

3. Use several drops of the primary broth tube to inoculate a #814 plate and/or #814 agar slant.
 4. Incubate at 37°C in 5% CO₂ for 18-24 hours.
