Gardnerella vaginalis strain UMB0143 is a bacterium commonly found in the vaginal and urinary microbiota. It was isolated in 2013 from a transurethral catheter urine sample obtained from a woman in Illinois.

For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open thawed vial.
2. Aseptically transfer the entire contents to a 5-6 mL tube of #814 broth.

Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.

3. Use several drops of the primary broth tube to inoculate a #814 plate and/or #814 agar slant.
4. Incubate at 37°C for 48-72 hours in an atmosphere of 5% CO₂.

Notes

It may be necessary to establish growth in broth before attempting growth in agar.
