Gardnerella vaginalis strain UMB0736 is a bacterium commonly found in the vaginal and urinary microbiota. It was isolated in 2014 from a transurethral catheter urine sample obtained from a woman in Illinois.

Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Medium:

ATCC Medium 260: Trypticase soy agar/broth with defibrinated sheep blood

Temperature: 37°C

Handling Procedures

1. Open thawed vial.
2. Aseptically transfer the entire contents to a 5-6 mL tube of #260 broth.

Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.

3. Use several drops of the primary broth tube to inoculate a #260 plate and/or #260 agar slant.
4. Incubate at 37°C for 72 hr in an atmosphere of 5% CO₂.
