Handling Procedures

1. Open vial.
2. Rehydrate the entire pellet with approximately 0.5 mL of #2043 broth.

Aseptically transfer the entire contents to a 5-6 mL tube of #2043 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.

3. Use several drops of the primary broth tube to inoculate a #2043 plate and/or #2043 agar slant.
4. Incubate at 37°C for 24 hours in an atmosphere of 5% CO₂.

Notes

You may also use Todd-Hewitt Broth (BD 211736) plus 0.5% yeast extract and 0.3 mcg/mL erythromycin or #44 Broth: Brain Heart Infusion (BD 237500) for growth. This strain is used to produce vaccine against pneumococcal infection (Briles DE, *et al*., US Patent 5,476,929).
