*Burkholderia savannae* strain MSMB266 is a soil-derived type strain from tropical northern Australia. It shows intrinsic resistance to gentamicin and streptomycin and is commonly used as a near-neighbor negative control to ensure specificity of PCR tests targeting the Tier 1 Select Agent *Burkholderia pseudomallei*.

2. Aseptically transfer the entire contents to a 5-6 mL tube of #18 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
  3. Use several drops of the primary broth tube to inoculate a #18 plate and/or #18 agar slant.
  4. Incubate at 37°C for 48 hours.
