For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

# Handling Procedures

- 1. Open the vial according to enclosed instructions.
- 2. From a single tube of #2307 broth (5 to 6 ml), withdraw approximately 0.5 to 1 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #2307 agar slant and/or plate.

5. Incubate all tubes and plate at 50°C for 48 to 72hours.

#### Notes

Robritepida focculans is a Gram-negative motile short rod. To obtain the best growth in broth incubate the culture with shaking. Cells may come off in a sheet when taken from a slant or plate. The culture exhibits a pink to red pigmentation.
