Handling Procedures

1. Open vial.
2. From a single tube of #416 broth (5 to 6 mL), withdraw approximately 0.5 to

- 1.0 mL with a Pasteur or 1.0 mL pipette and use to rehydrate the entire pellet.
 3. Use 0.1 mL of this suspension to inoculate #416 slants and 0.1mL to inoculate #416 plates.
 4. Incubate tubes and plates at 30°C, under aerobic conditions, for 48 hours.
 5. After 48 hours of incubation, wash cells from the slant and transfer this broth to a new slant and plate. Incubate another 48 hours under aerobic conditions. This second transfer and incubation is necessary for complete removal of the cryoprotectant, which can inhibit growth. Increased 5% CO₂ does not hasten growth.
