## Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #25 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #25 agar slant and/or plate.
- 5. Incubate the tubes and plate at 30°C for 72 to 96 hours.

#### Notes

Colonies on #25 agar are pink, circular, entire, convex, dull, and opaque.

The depositor states that this strain can degrade petroleum crude oil.
