- 2. Rehydrate the entire pellet with approximately 0.5 mL of #25 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #25 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.

- 3. Use several drops of the primary broth tube to inoculate a #25 plate and/or #25 agar slant.
- 4. Incubate at 30°C for 72 to 96 hours.
