### Handling Procedures

Centrifuge tube prior to opening to prevent loss of pelleted material

- 1. Rehydrate contents of vial with molecular grade H<sub>2</sub>O.
- 2. Place vial at 37°C for 1 hour or at 2°C to 8°C overnight.
- 3. For more complete rehydration and to fully recover DNA, incubate the sample overnight at 4°C while rocking; then incubate for 1 hour at 65°C. Resuspending the dried DNA in  $\geq$  250 µL may give better results.

## **Quality Control Specifications**

Electrophoresis - RNA content: No RNA was detected by electrophoresis Total amount: Total DNA by PicoGreen<sup>®</sup> measurement was found to be approximately 5 µg. Purity (A260/A280): 1.6 to 2.0 Integrity: Integrity of DNA was determined by electrophoresis on a 1% agarose gel stained with SYBR Safe<sup>™</sup>, and was found to be of high molecular weight. Functional tests: Functional activity was confirmed by PCR amplification of the 16S ribosomal RNA gene.
