Temperature: 26°C **Atmosphere:** 80% N₂, 20% CO₂

Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Under anaerobic conditions, withdraw 0.5 mL of #2361 from a single test tube (5 to 6 mL) and rehydrate the entire vial contents.
- 3. Aseptically transfer this aliquot back into the broth tube. Additional tubes may be inoculated with 0.5 mL each from the suspension. A slant and plate of #2361 may also be inoculated with 0.2 mL.
- 4. Incubate tubes, slants and plates under an anaerobic atmosphere at 26°C.

ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber, or
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber,
- Loose screw caps on test tubes in an activated anaerobic gas pack jar, or
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

Notes

This organism is a facultative anaerobe, thus it will reduce the medium #2361 after inoculation. Therefore the medium does not need to be reduced prior to being inoculated; however the gas in the head space of the anaerobic test tube should be exchanged for $80\% N_2$ - $20\% CO_2$.

This organism will grow on Nutrient Agar (BD 213000) under aerobic conditions. Colonies are pinpoint, circular, and translucent. Cells appear as small thin curved rods that occur singly and in pairs.
