Citrobacter farmeri strain CDC 2427-97 is a drug-resistant bacterial strain that was isolated in 1997 from human urine in Chicago, Illinois. This strain is cited to produce extended spectrum beta-lactamase (ESBL).

Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

1. Open vial.
2. From a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.

4. Use several drops of this suspension to inoculate an additional broth tube, a #18 agar slant and/or a plate.
 5. Incubate the tubes and plate at 37°C for 24 hours.

Notes

On #18 plates colonies are entire, glistening, smooth, and convex. Cells are motile short rods, stained Gram negative, occurring singly or in pairs.
