Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Under anaerobic conditions, withdraw 0.5 ml of the recommended broth from a single test tube (5 to 6 ml) and rehydrate the entire vial contents.
- 3. Aseptically transfer this aliquot back into the broth. Additional tubes may be inoculated with 0.5 ml each from the suspension. Also, 0.1 ml may be inoculated onto

- a slant. Streak plates to check for colonial morphology and purity.
- 4. Incubate tubes under an anaerobic atmosphere at 20°C. Incubate one agar plate anaerobically for colony formation, and one aerobically.
- 5. Within 2-4 days, growth should be evident in the broth tubes. Colonies on agar may take longer.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- ·Use of an anaerobic gas chamber, or
- · Placement of test tubes under a gassing cannula system

hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- ·Loose screw caps on test tubes in anaerobic chamber,
- ·Loose screw caps on test tubes in an activated anaerobic

gas pack jar, or

·Use of sterile butyl rubber stoppers on test tubes so that

an anaerobic gas headspace is retained.

### Notes

This organism is a Gram-positive cocci able to grow facultatively. Growth takes 2-4 days in broth and longer on solid media. Two colony types can be found. One is creamy and another is translucent and pinpoint. Grows well both anaerobically and aerobically on Brain Heart Infusion.
