## Handling Procedures

1. Open vial according to enclosed instructions.
  2. Using a single tube of #2061 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
  3. Aseptically transfer this aliquot back into the broth tube. Mix well.
  4. Use several drops of the suspension to inoculate an additional broth tube, a #2061 agar slant and/or a plate.
  5. Incubate all tubes and plate at 30°C for 72-96 hours.

Colonies on #2061 plates, colonies are smooth, entire, convex, mucoid, and bright yellow.
