Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #220 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #220 agar slant and/or plate.
- 5. Incubate the tubes and plate at 30°C for 3-5 days.

Notes

Colonies on #220 agar are raised, smooth, glistening, and have irregular centers with filamentous spreading edges. Colonies are light yellow, turing light pink and then orange with age.

It is recommened to establish growth in the primary broth before transferring to additional media.

Fruiting bodies may or may not be observed. Deliquescent mounds may be observed instead of fruiting bodies.
