Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. From a single tube of the recommended broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the entire pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
- 4. Heavily inoculate a slant and/or a plate of the desired agar.
- 5. After growth has been achieved, additional transfers may be made.

Notes

Growth on solid medium will take 7 days. Colonies on agar surfaces are buff, smooth, circular, low convex and entire.
