For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

- 1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
- 2. Under anaerobic conditions aseptically rehydrate the entire pellet with approximately 0.5 mL of #1942 broth. Aseptically transfer the entire contents

to a 5-6 mL tube of #1942 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes. Best practice dictates the use of prereduced media.

- 3. Use several drops of the primary broth tube to inoculate a #260 plate.
- 4. Incubate in an anaerobic atmosphere at 60°C to 100°C for 72 hours. Incubate one agar plate aerobically at 37°C to check for contamination.

#### Notes

This organism does not grow well on agar. The #260 plate is to check for purity. Always use freshly prepared pre-reduced media or pre-reduced media that has been previously prepared but stored under anaerobic conditions.
