Description

UMNSAH/DF-1 is a spontaneously immortalized chicken cell line. Primary chicken embryonic fibroblasts were dissociated and grown in culture; the fibroblasts were passaged until they began to senesce; the cells were concentrated during cell senescence to maintain about 30% to about 60% culture confluence. The cells are useful as substrates for virus propagation, recombinant protein expression, and recombinant virus production. This product is an ATCC manufactured and accessioned progeny of ATCC CRL-12203 cited in US Pat. No. 5,672,485. **Organism:** *Gallus gallus*, chicken **Cell Type:** fibroblast **Tissue:** Embryo **Age:** 10 days gestation **Morphology:** fibroblast **Growth properties:** Adherent

Unpacking and storage instructions:

- 1. Check all containers for leakage or breakage.
- 2. Remove the frozen cells from the dry ice packaging and immediately place the cells at a temperature below -130°C, preferably in liquid nitrogen vapor, until ready for use.

Complete medium: The base medium for this cell line is ATCC-formulated Dulbecco's Modified Eagle's Medium, Catalog (ATCC 30-2002). To make the complete growth medium, add the following components to the base medium: fetal bovine serum (ATCC 30-2020) to a final concentration of 10%.

Handling Procedure:

To insure the highest level of viability, thaw the vial and initiate the culture as soon as possible upon receipt. If upon arrival, continued storage of the frozen culture is necessary, it should be stored in liquid nitrogen vapor phase and not at -70°C. Storage at -70°C will result in loss of viability.

- Thaw the vial by gentle agitation in a 37-39°C water bath. To reduce the possibility of contamination, keep the O-ring and cap out of the water. Thawing should be rapid (approximately 2 minutes).
- Remove the vial from the water bath as soon as the contents are thawed, and decontaminate by dipping in or spraying with 70% ethanol. All of the operations from this point on should be carried out under strict aseptic conditions.
- 3. Transfer the vial contents to a centrifuge tube containing 9.0 mL complete growth medium and spin at approximately 125 x g for 5 to 7 minutes.
- 4. Resuspend cell pellet with the recommended complete growth medium (see the specific batch information for the recommended dilution ratio).. It is important to avoid excessive alkalinity of the medium during recovery of the cells. It is suggested that, prior to the addition of the vial contents, the culture vessel containing the growth medium be placed into the incubator for at least 15 minutes to allow the medium to reach its normal pH (7.0 to 7.6).
- Incubate the culture at **39°C** in a suitable incubator. A 5% CO₂ in air atmosphere is recommended if using the medium described on this product sheet.

Subculturing procedure:

Volumes are given for a 75 cm² flask. Increase or decrease the amount of dissociation medium needed proportionally for culture vessels of other sizes.

- 1. Remove and discard culture medium.
- 2. Briefly rinse the cell layer with 0.25% (w/v) Trypsin- 0.53 mM EDTA solution to remove all traces of serum that contains trypsin inhibitor.
- 3. Add 2.0 to 3.0 mL of Trypsin-EDTA solution to flask and observe cells under an inverted microscope until cell layer is dispersed (usually within 5 to 15 minutes).

Note: To avoid clumping do not agitate the cells by hitting or shaking the flask while waiting for the cells to detach. Cells that are difficult to detach may be placed at 39°C to facilitate dispersal.

- 4. Add 6.0 to 8.0 mL of complete growth medium and aspirate cells by gently pipetting.
- 5. Add appropriate aliquots of the cell suspension to new culture vessels.
- 6. Incubate cultures at 39°C.

Subcultivation Ratio: A subcultivation ratio of 1:2 to 1:10 is recommended **Medium Renewal:** Twice per week

Reagents for cryopreservation: Complete growth medium supplemented with 5% (v/v) DMSO (ATCC 4-X)
