## Description

This cell line was derived from the C127I (see ATCC CRL-1616) mouse cell line by transformation with a bovine papilloma virus vector (pRB-1) containing the DNA sequence encoding HBsAg.

HBsAg production is under the control of the metallothionine promoter. This material is ATCC manufactured progeny created from a sample of the patent deposit CRL-8399, cited in US Pat No. US 4,696,898.

## Handling Procedures

### Unpacking and storage instructions:

1. Check all containers for leakage or breakage.
2. Remove the frozen cells from the dry ice packaging and immediately place the

cells at a temperature below  $-130^{\circ}\text{C}$ , preferably in liquid nitrogen vapor, until ready for use.

**Complete medium:** The base medium for this cell line is ATCC-formulated Dulbecco's Modified Eagle's Medium, Catalog No. 30-2002. To make the complete growth medium, add the following components to the base medium: fetal bovine serum to a final concentration of 10%.

**Handling Procedure:** To ensure the highest level of viability, thaw the vial and initiate the culture as soon as possible upon receipt. If upon arrival, continued storage of the frozen culture is necessary, it should be stored in liquid nitrogen vapor phase and not at  $-70^{\circ}\text{C}$ . Storage at  $-70^{\circ}\text{C}$  will result in loss of viability.

1. Thaw the vial by gentle agitation in a  $37^{\circ}\text{C}$  water bath. To reduce the possibility of contamination, keep the O-ring and cap out of the water. Thawing should be rapid (approximately 2 minutes).
2. Remove the vial from the water bath as soon as the contents are thawed, and decontaminate by dipping in or spraying with 70% ethanol. *All of the operations from this point on should be carried out under strict aseptic conditions.*
3. Transfer the vial contents to a centrifuge tube containing 9.0 mL complete growth medium and spin at approximately  $125 \times g$  for 5 to 7 minutes. Discard supernatant.
4. Resuspend the cell pellet with the recommended complete growth medium (see the specific batch information for the culture recommended dilution ratio) and dispense into a  $25 \text{ cm}^2$  or a  $75 \text{ cm}^2$  culture flask. It is important to avoid excessive alkalinity of the medium during recovery of the cells. *It is suggested that, prior to the addition of the vial contents, the culture vessel containing the complete growth medium be placed into the incubator for at least 15 minutes to allow the medium to reach its normal pH (7.0 to 7.6).*
5. Incubate the culture at  $37^{\circ}\text{C}$  in a suitable incubator. A 5%  $\text{CO}_2$  in air atmosphere is recommended if using the medium described on this product sheet.

**Subculturing procedure:**

**Subcultivation Ratio:** A subcultivation ratio of 1:5 to 1:15 is recommended

**Medium Renewal:** 2 to 3 times per week

Remove medium, rinse with fresh 0.25% trypsin, 0.03% EDTA solution for 2 to 3 minutes, remove trypsin and let the culture sit at room temperature (or  $37^{\circ}\text{C}$ ) until cells detach (about 10 minutes). Add fresh medium, aspirate and dispense, into new flasks.

**Reagents for cryopreservation:** Fetal Bovine Serum (ATCC 30-2020) supplemented

with 10% (v/v) Glycerol
