Handling Procedures

Complete medium: Dulbecco's modified Eagle's medium, with HAT 80%; fetal bovine serum, 20%

Handling Procedure: Part A. FROZEN CELLS

Vol./Ampule: 1.0 mL.

Recommended Handling Upon Receipt: Initiate culture as soon as possible upon receipt. Thaw by rapid agitation in 37°C water bath. See instructions on back.

Dilute ampule contents with culture medium (see batch data above). Add fresh medium (depending on cell density) every 2-3 days.

Subculturing procedure:

Medium Renewal: Every 2 to 3 days

Cultures can be maintained by addition or replacement of fresh medium. Start cultures at 2×10^5 cells/ml and maintain between 1×10^5 and 1×10^6
