Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

Temperature: 37°C

Handling Procedures

Unpacking and storage instructions:

1. Check all containers for leakage or breakage.
2. Remove the frozen cells from the dry ice packaging and immediately place the cells at a temperature below -130°C, preferably in liquid nitrogen vapor, until ready for use.

Complete medium: HL-1 medium, 99%; fetal bovine serum, 1%. Iscove's modified Dulbecco's medium with 10% fetal bovine serum has been used as an alternative to HL-1

Handling Procedure: Part A. FROZEN CELLS

Vol./Ampule: 1.0 mL.

Recommended Handling Upon Receipt: Initiate culture as soon as possible upon receipt. Thaw by rapid agitation in 37°C water bath. See instructions on back.

Dilute ampule contents with culture medium (see batch data above).

Subculturing procedure:

Medium Renewal: Every 2 to 3 days

Cultures can be maintained by addition or replacement of fresh medium. Start cultures at 5×10^4 cells/ml and maintain between 5×10^4 and 1×10^6 cells/ml.

Reagents for cryopreservation: HL-1 medium supplemented with 10% (v/v) human serum albumin and 7.5% (v/v) DMSO (ATCC 4-X)
