Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

Unpacking and storage instructions:

- 1. Check all containers for leakage or breakage.
- 2. Remove the frozen cells from the dry ice packaging and immediately place the cells at a temperature below -130°C, preferably in liquid nitrogen vapor, until ready for use.

Complete medium: The base medium for this cell line is ATCC-formulated Dulbecco's Modified Eagle's Medium, Catalog No. 30-2002. To make the complete growth medium, add the following components to the base medium: fetal bovine serum to a final concentration of 10%.

Handling Procedure: Part A. FROZEN CELLS

Vol./Ampule: 1.0 mL.

Recommended Handling Upon Receipt: Initiate culture as soon as possible upon receipt. Thaw by rapid agitation in 37°C water bath. See instructions on back. Dilute ampule contents with culture medium (see batch data above). Add fresh medium as density increases. Mouse peritoneal macrophage or X-irradiated murine

fibroblasts (e.g. ATCC X55, STO) feeder cells are necessary for the recovery, growth and expansion of the TB28-2 hybrid.

Subculturing procedure:

Medium Renewal: Every 3 to 4 days

Cultures can be maintained by addition or replacement of fresh medium. Start cultures at 2 X 10 exp5 cells/ml and maintain between 1 X 10 exp5 and 1 X 10 exp6 cells/ml.

Reagents for cryopreservation: Complete growth medium supplemented with 5% (v/v) DMSO (ATCC 4-X)
