Handling Procedures

Unpacking and storage instructions:

1. Check all containers for leakage or breakage.
2. Remove the frozen cells from the dry ice packaging and immediately place the cells at a temperature below -130°C , preferably in liquid nitrogen vapor, until

ready for use.

Complete medium: RPMI 1640 medium with 1 mM sodium pyruvate, 85%; fetal bovine serum, 15%

Handling Procedure: Part A. FROZEN CELLS

Vol./Ampule: 1.0 mL.

Recommended Handling Upon Receipt: Initiate culture as soon as possible upon receipt. Thaw by rapid agitation in 37°C water bath. See instructions on back.

Dilute ampule contents with culture medium (see batch data above). Add fresh medium (depending on cell density) every 2-3 days.

Subculturing procedure:

Medium Renewal: 2 to 3 times per week

Cultures can be maintained by addition or replacement of fresh medium. Start cultures at 1×10^5 cells/ml and maintain between 1×10^5 and 1×10^6 cells/ml.

Reagents for cryopreservation: Modified Dulbecco's medium supplemented with 10% (v/v) FBS and 5% (v/v) DMSO (ATCC 4-X)
