#### Unpacking and storage instructions:

1. Check all containers for leakage or breakage.
2. Remove the frozen cells from the dry ice packaging and immediately place the cells at a temperature below  $-130^{\circ}\text{C}$ , preferably in liquid nitrogen vapor, until

ready for use.

**Complete medium:** RPMI 1640 medium with 1 mM sodium pyruvate, 85%; fetal bovine serum, 15%

**Handling Procedure:** Part A. FROZEN CELLS

Vol./Ampule: 1.0 mL.

Recommended Handling Upon Receipt: Initiate culture as soon as possible upon receipt. Thaw by rapid agitation in 37°C water bath. See instructions on back.

Dilute ampule contents with culture medium (see batch data above). Add fresh medium (depending on cell density) every 2-3 days.

**Subculturing procedure:**

**Medium Renewal:** Every 2 to 3 days

Cultures can be maintained by addition or replacement of fresh medium. Start cultures at  $2 \times 10^5$  cells/ml and maintain between  $1 \times 10^5$  and  $1 \times 10^6$  cells/ml.

**Reagents for cryopreservation:** Complete growth medium supplemented with 20% (v/v) fetal bovine serum (ATCC 30-2020) and 10% (v/v) DMSO (ATCC 4-X)
