Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

### Unpacking and storage instructions:

1. Check all containers for leakage or breakage.
2. Remove the frozen cells from the dry ice packaging and immediately place the cells at a temperature below  $-130^{\circ}\text{C}$ , preferably in liquid nitrogen vapor, until ready for use.

**Complete medium:** The base medium for this cell line is ATCC-formulated Dulbecco's Modified Eagle's Medium, Catalog No. 30-2002. To make the complete growth medium, add the following components to the base medium: fetal bovine serum to a final concentration of 10%.

### Handling Procedure:

#### Part A. FROZEN CELLS

**Vol./Ampule: 1.0 mL.**

**Recommended Handling Upon Receipt: Initiate culture as soon as possible upon**

**receipt. Thaw by rapid agitation in 37°C water bath. See instructions on back.**

**Dilute ampule contents with culture medium (see batch data above). Add fresh medium as density increases. A feeder layer of mouse peritoneal macrophages or X-irradiated murine fibroblast cells (e.g. ATCC X56, STO) is recommended in the initial recovery of the cells from the frozen state.**

- **Subculturing procedure:**

**Medium Renewal:** Every 2 to 3 days

Cultures can be maintained by addition or replacement of fresh medium. Start cultures at  $2 \times 10^5$  cells/ml and maintain between  $1 \times 10^5$  and  $1 \times 10^6$  cells/ml.
