## Unpacking and storage instructions:

1. Check all containers for leakage or breakage.
2. Remove the frozen cells from the dry ice packaging and immediately place the cells at a temperature below  $-130^{\circ}\text{C}$ , preferably in liquid nitrogen vapor, until ready for use.

**Complete medium:** Dulbecco's modified Eagle medium, 90%; fetal bovine serum, 10%.

## Handling Procedure: Part A. FROZEN CELLS

Vol./Ampule: 1.0 mL.

Recommended Handling Upon Receipt: Initiate culture as soon as possible upon receipt. Thaw by rapid agitation in  $37^{\circ}\text{C}$  water bath. See instructions on back.

Dilute ampule contents with culture medium (see batch data above). Dispense into a 75 sq. cm. flask.

## Subculturing procedure:

**Medium Renewal:** Every 2 to 3 days
