Description

The MicroQuant™ Antimicrobial Effectiveness Panel comprises the five microbial challenge organisms cited in United States Pharmacopeia chapter 51 (USP <51>) for use in evaluating the efficacy of antimicrobial preservatives added to aqueous pharmaceutical products. Each component is provided as a pack containing 5 vials of cryopreserved pellets (10⁷ to 10⁸ CFU per vial) and 5 vials of rehydration buffer. This panel is provided at a 20% discount as compared to purchasing the individual strains separately.

ATCC 10231-HQ-PACK and ATCC 6538-HQ-PACK require a valid permit before they can be shipped. Please refer to the Permits & Restrictions for more information on what is required.
