Description

The MicroQuant™ Microbial Examination of Nonsterile Products: Tests for *Burkholderia cepacia* Complex Panel comprises the three microbial challenge organisms cited in United States Pharmacopeia chapter 60 (USP <60>) for use in detecting *Burkholderia cepacia* complex strains in non-sterile, water-based pharmaceutical products. Each component is provided as a pack containing 5 vials of cryopreserved pellets (100 to 1,000 CFU per pellet, supporting 10 assays per pellet) and 5 vials of rehydration buffer.
