Description

The MicroQuant™ Microbial Enumeration of Nonsterile Products Panel comprises the five microbial challenge organisms cited in United States Pharmacopeia chapter 61 (USP <61>) for use in evaluating the number of viable microorganisms in a nonsterile product. Each component is provided as a pack containing 5 vials of cryopreserved pellets (100 to 1,000 CFU per vial, supporting 10 assays per vial) and 5 vials of rehydration buffer. This panel is provided at a 20% discount as compared to purchasing the individual strains separately.

ATCC 10231-LQ-PACK and ATCC 6538-LQ-PACK require a valid permit before they can be shipped. Please refer to the [Permits & Restrictions](#) for more information on what is required.

MicroQuant™ *Candida albicans*, low CFU (ATCC 10231-LQ-PACK)

MicroQuant™ *Bacillus spizizenii*, low CFU (ATCC 6633-LQ-PACK)

MicroQuant™ *Pseudomonas paraeruginosa*, low CFU (ATCC 9027-LQ-PACK)

MicroQuant™ *Staphylococcus aureus* subsp. *aureus*, low CFU (ATCC 6538-LQ-PACK)

Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.
