## Handling Procedures

**Frozen ampoules** packed in dry ice should either be thawed immediately or stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampoules may be stored at or below -70°C for approximately one week. **Do not under any**

**circumstance store frozen ampoules at refrigerator freezer temperatures (generally -20°C).** Storage of frozen material at this temperature will result in the death of the culture.

1. Frozen ampoules packed in dry ice should either be thawed immediately or stored in liquid nitrogen vapor. If liquid nitrogen storage facilities are not available, frozen ampoules may be stored at or below -70°C for approximately one week. **Do not under any circumstance store frozen ampoules at refrigerator freezer temperatures (generally -20°C).** Storage of frozen material at this temperature may result in the death of the culture.
2. To thaw a frozen ampoule (or plastic vial), place it in a water bath maintained at 25-30°C until it just thawed (around 5 minutes)." Immerse the ampoule just enough to cover the frozen material. Do not agitate the ampoule.
3. Immediately after thawing, aseptically transfer the contents of the vial onto appropriate moist solid or liquid medium.
4. Incubate cultures at recommended temperature.

## Notes

Plant pathogen; Listed as a key isolate of the species in Gallegly and Hong (2008); this strain may require a primary growth period in a nutrient broth containing trace amount of biotin and thiamine (ATCC medium 2232) before it will grow on any subculture attempts.
