## Growth Conditions

### Medium:

ATCC Medium 324: Malt extract agar

ATCC Medium 336: Potato dextrose agar (PDA)

**Temperature:** 20-25°C

## Handling Procedures

**Frozen ampoules** packed in dry ice should either be thawed immediately or stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampoules may be stored at or below -70°C for approximately one week. **Do not under any circumstance store frozen ampoules at refrigerator freezer temperatures (generally -20°C).** Storage of frozen material at this temperature will result in the death of the culture.

1. To thaw a frozen ampoule, place in a **2530 °C** water bath, until just thawed ( **approximately 5 minutes**). Immerse the ampoule just sufficient to cover the frozen material. Do not agitate the ampoule.
2. Immediately after thawing, wipe down ampoule with 70% ethanol and aseptically transfer at least 50 µl (or 2-3 agar cubes) of the content onto a plate or broth with medium recommended.
3. Incubate the inoculum/strain at the temperature and conditions recommended.
4. Inspect for growth of the inoculum/strain regularly. The sign of viability is noticeable typically after 1-2 days of incubation. However, the time necessary for significant growth will vary from strain to strain.

**Morphology:** On potato dextrose medium after 3 days at 25C, Colonies white to grayish white, cottony, aerial mycelium completely fills petri dish within 7-10days. Sporangiophores with sympodial branching pattern, 81µm long by 5µm wide. Sporangia globose, 18-24µm X 12-24µm. Sporangiospores globose to ovoid, 6-10.5µm X 6-9µm, thick walled. Chlamydospores single or in chains, globose to subglobose, 15-17.5µm X 15µm. Columellae conical, 20-45µm X 12-22.5µm.

Type strain of the species; clinical isolate; grows at 37C; Mucor sp. 1 sensu Alvarez et al. (J. Clin. Microbiol. 47: 1650-1665, 2009).
