Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submerged in liquid nitrogen.

Handling Procedures

Frozen ampoules packed in dry ice should either be thawed immediately or stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampoules may be stored at or below -70°C for approximately one week. **Do not under any circumstance store frozen ampoules at refrigerator freezer temperatures**

(generally -20°C). Storage of frozen material at this temperature will result in the death of the culture.

1. To thaw a frozen ampoule, place in a **25°C to 30°C** water bath, until just thawed (**approximately 5 minutes**). Immerse the ampoule just sufficient to cover the frozen material. Do not agitate the ampoule.
2. Immediately after thawing, wipe down ampoule with 70% ethanol and aseptically transfer 50 µL (or any amount desired up to all) of the content onto a plate or broth with medium recommended.
3. Incubate the inoculum/strain at the temperature and conditions recommended.
4. Inspect for growth of the inoculum/strain regularly. The sign of viability is noticeable typically after 2-3 days of incubation. However, the time necessary for significant growth will vary from strain to strain.

Morphology: After 2 to 3 days at 25°C on YM medium colonies are brown to dark brown in color, at first usually smooth becoming finely floccose or somewhat funiculose. Conidiogenous cells arising from undifferentiated hyphae, forming conidia sympodially on few denticles. Sympodial conidia are hyaline to subhyaline and obovoidal. Sessile conidia are brown to dark brown and globose to subglobose.

Notes

Grows as mycelia at 25°C and as yeast at 37°C.
