ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

Frozen ampoules packed in dry ice should either be thawed immediately or stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampoules may be stored at or below -70°C for approximately one week. **Do not under any circumstance store frozen ampoules at refrigerator freezer temperatures**

(generally -20°C). Storage of frozen material at this temperature will result in the death of the culture.

- 1. To thaw a frozen ampoule, place in a 25°C to 30°C water bath, until just thawed (approximately 5 minutes). Immerse the ampoule just sufficient to cover the frozen material. Do not agitate the ampoule.
- 2. Immediately after thawing, wipe down ampoule with 70% ethanol and aseptically transfer 50 μ L (or 2 to 3 agar cubes) of the content onto a plate or broth with medium recommended.
- 3. Incubate the inoculum/strain at the temperature and conditions recommended.
- 4. Inspect for growth of the inoculum/strain regularly. The sign of viability is noticeable typically after 2 to 3 days of incubation. However, the time necessary for significant growth will vary from strain to strain.

Morphology: On PDA medium at 25°C after 9 days, mycelium white, densely floccose, abundant aerial hyphae. Conidia developing in pustules, lime green to green. After 12 days, hyphae guttluate. Conidiophores with branched with terminal whorls of phialides. Phialides ampulliform. Conidia green in mass, hyaline to pale greenish singly, cylindrical to ellipsoidal, smooth, 4.5-5.25 μm x 3 μm. Chlamydospores present.
