Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Growth Conditions

### Medium:

ATCC Medium 200: YM agar or YM broth

## Handling Procedures

**Frozen ampoules** packed in dry ice should either be thawed immediately or stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampoules may be stored at or below -70°C for approximately one week. **Do not under any circumstance store frozen ampoules at refrigerator freezer temperatures**

(generally -20°C). Storage of frozen material at this temperature will result in the death of the culture.

1. To thaw a frozen ampoule, place in a **25°C to 30°C** water bath, until just thawed (**approximately 5 minutes**). Immerse the ampoule just sufficient to cover the frozen material. Do not agitate the ampoule.
2. Immediately after thawing, wipe down ampoule with 70% ethanol and aseptically transfer at least 50 µL (or 2-3 agar cubes) of the content onto a plate or broth with medium recommended.
3. Incubate the inoculum/strain at the temperature and conditions recommended.
4. Inspect for growth of the inoculum/strain regularly. The sign of viability is noticeable typically after 3-5 days of incubation. However, the time necessary for significant growth will vary from strain to strain.

**Morphology:** After 7 days on Potato dextrose agar at 25°C, colonies olive-green, flat, powdery, mycelium white, reverse uncolored. Conidial heads radiate; stipes rough-walled, hyaline; vesicles pyriform, uniseriate. Conidia globose, smooth-walled, green.
