Description

Neofusicoccum parvum strain ON1 is a fungal isolate belonging to the family Botryosphaeriaceae. This strain was isolated from hemp (*Cannabis sativa*) plants showing dieback symptoms in Searcy County, Arkansas, USA, in 2019. This strain was identified using molecular methods, including whole-genome sequencing. It exhibits virulence-associated properties that cause dieback symptoms in hemp plants. This product is provided as an ampoule containing viable cells (may include spores and mycelia) suspended in cryoprotectant.

Handling Procedures

Frozen ampoules packed in dry ice should either be thawed immediately or stored in liquid nitrogen. If liquid nitrogen storage facilities are not available, frozen ampoules may be stored at or below -70°C for approximately one week. **Do not under any circumstance store frozen ampoules at refrigerator freezer temperatures (generally -20°C).** Storage of frozen material at this temperature will result in the death of the culture.

1. To thaw a frozen ampoule, place in a **28°C to 32°C** water bath, until just thawed (**approximately 5 minutes**). Immerse the ampoule just sufficient to cover the frozen material. Do not agitate the ampoule.
2. Immediately after thawing, wipe down ampoule with 70% ethanol and aseptically transfer at least 50 µL (or 2-3 agar cubes) of the content onto a plate or broth with medium recommended.
3. Incubate the inoculum/strain at the temperature and conditions recommended. Inspect for growth of the inoculum/strain regularly. The sign of viability is noticeable typically after 2-3 days of incubation. However, the time necessary for significant growth will vary from strain to strain

Morphology: On 336 agar after 3 days at 25°C, colonies are white, grey, to black. Texture is floccose to powdery, with abundant aerial mycelium. Reverse is black.
