An entry vector carrying a strong constitutive promoter (374 bp) flanked by two *att* sites (*att* L4 and *att* R1). It is the translation elongation factor (TEF) promoter from *Ashbya gossypii* (*Eremothecium gossypii*), which is a filamentous fungus closely related to *S. cerevisiae*. This promoter is part of the ATCC® Synthetic Biology Yeast Tool Kit (Detailed information is described in the ATCC® [Synthetic Biology Solutions User Guide](#)).

Before opening the vial, centrifuge at 6,000 x g for 30 seconds. Add 30 µL of Molecular Grade Water and incubate the vial at 4°C overnight to dissolve the DNA. Each vial contains 2-3 µg plasmid DNA (measured by PicoGreen® dsDNA quantitation assay).
